- Accident Waiver & Release of Liability –

I _____, (print name) hereby knowingly and voluntarily accept all risk to my safety and/or health in participating in any/all activities associated with this COMMUNING WITH ELEPHANTS TOUR, (CET), in Kenya on June 3 - 12, 2018, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, because of their possible liability without fault. loss and damages which they or any of them may suffer as a result of claims, demands, suits, costs or judgments against them or any of them, including any attorney's fees and court costs resulting from any related illness, death or incident associated with my travel, and hereby release, hold harmless and indemnify the organizer, Ruth Yeatman, (RY), the Tour Operator, Fact Safaris, (FS), and all of their staff, Wynter Worsthorne, (WW), AnimalTalk Africa (ATA) and the David Sheldrick Wildlife Trust and all of their staff, (DSWT).

I certify that I am physically and psychologically fit and have sufficiently prepared or trained for participation in this activity, and there are no health related reasons or problems which preclude my participation in this activity. I have consulted with qualified medical professionals and have been advised that I am fit to participate in the Elephant Voices 2018 tour. I will advise organizers prior to registration if I am currently suffering from psychological or nervous condition, or taking any prescribed medication for the treatment of the aforementioned or any other medical condition. I understand and accept the organizers have the right to refuse my participation. Should such a condition(s) develop after registration I will advise the organizers and if my participation in the CET tour is deemed unsuitable I shall receive a full refund of any fees I paid.

In consideration of my application and permitting me to participate in this activity, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assign as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this tour activity, THE FOLLOWING ENTITIES OR PERSON: Ruth Yeatman, Wynter Worsthorne, AnimalTalk Africa, Fact Safaris, The David Sheldrick Wildlife Trust, their staff, representatives, and agents.

(B) INDEMNITY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participating in this tour activity, whether caused by negligence of release or otherwise. I acknowledge that RY, FS, WW, ATA and DSWT and their directors, officers, staff, representatives and agents are NOT responsible for the errors, omissions, acts or failures to act of any party or entity conducting a specific activity on their behalf.

Completion of this present workshop is for my individual benefit only and I agree not to advertise and conduct workshops, seminars, presentations or otherwise teach Animal Communication to the public without becoming a certified instructor. Teaching the contents of this workshop to the public without certification – whether or not for personal financial gain – is in violation of this agreement.

This Accident Waiver and Release of the Liability and agreement Form shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
